Hi-Lo Audible Warning (HLAW) System

PURPOSE:

The purpose of this bulletin is to inform all personnel about the implementation of the Hi-Lo Audible Warning (HLAW) system within the Culver City Police Department. This system is a critical tool for emergency evacuations and must be used in strict compliance with department guidelines and California Vehicle Code 27002 CVC.

OVERVIEW OF THE HLAW SYSTEM:

The HLAW system has been added to patrol vehicle siren/light control panels as a dedicated "Hi-Lo" button. This system is intended exclusively for emergency evacuation orders and must not be used for any other purpose.

Public Awareness Campaign:

• A public information campaign will launch in March 2025, including a scheduled press conference to educate the community about the system's purpose and proper response.

Purpose & Use:

- The HLAW alerts the public to imminent danger and conveys the need for immediate evacuation.
- Unauthorized or indiscriminate use is strictly prohibited, as it may diminish public awareness of its intended purpose.
- When activating the HLAW, emergency lights should also be used to enhance visibility and warning effectiveness.

Operational Systems:

- 1. New "Pathfinder" system (latest patrol vehicles):
 - Emits a repeating Hi-Lo sound with intermittent voice messaging in English and Spanish: "This is the Culver City Police Department. This area is under evacuation order. Please evacuate immediately. Failure to evacuate could result in a loss of life."
- 2. Older "Smart-Controller" system (legacy vehicles):
 - Emits only the repeating Hi-Lo sound without voice messaging.
 - This system will be gradually phased out as newer vehicles are deployed.

LEGAL COMPLIANCE & USAGE GUIDELINES:

- HLAW is not considered a legal siren under 27002 CVC and must not be used while driving Code-3.
- All traffic laws must be followed while using the HLAW.
- If a Code-3 response is required, the HLAW must immediately be discontinued, and approved sirens ("Wail" or "Yelp") must be used instead.

TRAINING & IMPLEMENTATION:

- Training on the proper use and legal parameters of the HLAW system will be provided to all sworn personnel during upcoming patrol briefings.
- Supervisors must ensure compliance and report any misuse of the system.

CONCLUSION:

The implementation of the Hi-Lo Audible Warning System is a critical step in enhancing public safety during emergency evacuations. Proper use ensures clear, authoritative communication with the community while maintaining legal compliance and operational effectiveness.
